When & where do the Board meet?

The Board meets at least once a month and usually for around than 2 hours at a time. Most Board meetings are on the second Monday of every month and held in Long Crendon, although online attendance is also possible if needed.

- Maintaining an inclusive, enjoyable and financially sustainable football club
- Developing and expanding the football club to provide growth for additional players, teams and sponsors

What's the application process?

We're inviting applications via the link [here](#) and will follow a 2 phased process, shown below. The application window opens on Wednesday 22nd November and closes at 10pm on Friday 8th December with the appointment of applicable new Board members week commencing (w/c) 8th January '24:

- Phase 1:
 - All applications will be reviewed by the Board w/c 11th Dec
 - All applicants will be contacted by the Board no later than Thurs 14th Dec to either A) arrange an interview or B) notify that they have been unsuccessful

- Phase 2:
 - The interviews with the Board will be completed no later than Sat 6th Jan
 - All applicants will be contacted by the Board w/c 8th Jan to either A) offer a position on the Board or B) notify that they have been unsuccessful
 - Successful applicants will be appointed by the Board w/c 8th Jan '24 and will take up their position from the next meeting, expected to be Mon 15th January
